HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, and of the Act of the fifth year of Her late Majesty Queen Victoria (session two) chapter twenty-six, duly prepared and laid before His Majesty in Council a scheme bearing date the eleventh day of July, in the year one thousand nine hundred and seven, in the words

following, that is to say :-"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, and of the Act of the fifth year of Her late Majesty Queen Victoria (session two), chapter twenty-six, have prepared and now humbly lay before Your Majesty in Council the following scheme for authorizing certain sanitary improvements at the episcopal house of residence belonging to the See of Llandaff, which is known as The Palace, Llandaff.

"Whereas the Right Reverend Joshua Pritchard, now Bishop of Llandaff, is desirous that certain sanitary improvements should be made at the said episcopal house of residence, and has submitted to us the particulars of such improvements and we have approved the same.
