James, Heywood, in the county of Lancaster, and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint George, situate at Heap Bridge, as aforesaid.

"Now therefore, with the consent of the Right Reverend Edmund Arbuthnott, Bishop of the said diocese of Manchester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said new parish of Saint James, Heywood, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint George, situate at Heap Bridge, as aforesaid, and that'the same should be named 'The District Chapelry of Saint George, Heap Bridge.'

"And with the like consent of the said Edmund Arbuthnott, Bishop of the said diocese of Manchester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that matriages, baptisms, churchings, and burials, should be solemnized or performed at the said church of Saint George, situate at Heap Bridge, as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

registration thereof. "We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

## "The SCHEDULE to which the foregoing Representation has reference.

" "The District Chapelry of Saint George, Heap Bridge, being :---

"All that part of the new parish (sometime particular district) of Saint James, Heywood, in the county of Lancaster, and in the diocese of Manchester, which is bounded upon the north partly by the new parish of Birkle, otherwise Birtle, and partly by the new parish of Saint Paul, Bury, upon the west partly by the last named new parish, partly by the new parish of Saint Thomas, Bury, and partly by the new parish of Saint Peter, Bury, upon the greater part of the south by the new parish of Saint George, Unsworth, all in the said county and diocese, and upon the remaining sides, that is to say, upon the remaining part of the south and upon the east, by an imaginary line commencing upon the boundary which divides the said new parish of Saint George, Unsworth, from the said new parish of Saint James, Heywood, at the point known as Three-lane Ends where the road leading from Heap Bridge to Birch is joined by Heywood-road, and extending thence eastward along the middle of Heywood-road for a distance of twenty-one chains or thereabouts to its junction with Harwood's-road, and extending thence north-westward along the middle of Harwood's-road for a distance of eleven chains

meets the footpath which leads past Three Pits into Moss-lane, and extending thence first northwestward, then westward and then again northwestward along the middle of such footpath for a distance of twenty-seven chains or thereabouts to its junction with Moss-lane, and extending thence eastward along the middle of Moss-lane for a distance of eleven chains or thereabouts to the footbridge which connects Moss-lane with the footpath which leads into Bury Old-road at Yew Tree Farm, and extending thence first northward along the middle of the said foot-bridge and then first north-westward and then in other directions along the middle of the last mentioned footpath for a distance of thirty-eight chains and a half or thereabouts to the junction of such footpath with Bury Old-road, and extending thence westward along the middle of Bury Old-road for a distance of six chains or thereabouts to its junction with the footpath leading into Bury New-road at Boohole Farm, and extending thence first north-westward and then northward along the middle of such foot-path for a distance of fifteen chains or thereabouts to its junction with Bury New-road, and extending thence westward along the middle of Bury New-road for a distance of eleven chains or thereabouts to its junction with Coalpit-lane, and extending thence north-westward along the middle of Coalpit-lane for a distance of fourteen chains or thereabouts to its northern end, and extending thence in a straight line due north for a distance of six chains or thereabouts to a point in the middle of the River Roch upon the boundary which divides the said new parish of Saint James, Heywood, from the said new parish of Birkle, otherwise Birtle."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.
