Motor Car Act, 1903. Regulations under Section 8.

COUNTY OF MIDDLESEX, BARGE WALK, HAMPTON COURT PARK.

To the First Commissioner of His Majesty's Works and Public Buildings; -

To the County Council of Middlesex;— And to all others whom it may concern.

Whereas by Section 8 of the Motor Car Act, 1903, it is provided that We, the Local Government Board, may, by Regulations made under Section 6 of the Locomotives on Highways Act, 1896, prohibit the driving of any motor cars, or of any special kind of motor cars, on any specified highway, or part of a highway, which does not exceed sixteen feet in width, or on which ordinary motor car traffic would, in Our opinion, be especially dangerous;

And whereas the First Commissioner of His Majesty's Works and Public Buildings having represented to Us that a Regulation should be made in pursuance of the above-mentioned sections prohibiting the driving of motor cars on a certain highway adjoining Hampton Court Park, in the county of Middlesex, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and an Inquiry was held accordingly, and Report has been made to Us thereon:

Now therefore, in pursuance of the powers given to Us in that behalf, We do hereby, by this Our Order, make the following Regulations:—

ARTICLE I.—A person shall not drive a motor car on the highway known as Barge-walk, extending from Kingston Bridge to Hampton Court Bridge and situate between the River Thames and Hampton Court Park, in the county of Middlesex.

ARTICLE II.—These Regulations shall come into operation on the thirtieth day of September, one thousand nine hundred and seven.

# THE MOTOR CAR ACT, 1903.

Borough of Bromley.

HEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the Council of the borough of Bromley have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following roads or parts of roads within the borough, that is to say:—

Beckenham-lane, extending from its junction with the main London road to the boundary of the borough; so much of the main London road (including High-street) as extends from its junction with Hope Park to a point in the main road situate 1 furlong or thereabouts south of its junction with the road lately known as South Hill, and now known as Cromwell-avenue; East-street; Plaistow-lane, extending from its junction with Nichol-lane to its junction with Widmore-road;

Tweedy-road; Widmore-road, extending from its junction with Market-square to its junction with Tylney-road; Park-road; Upper Park-road; Market-square.

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 11th day of June, 1907, in the "Bromley Chronicle" of the 13th day of June, 1907, and in the "Bromley and District Times" of the 14th day of June, 1907:

# ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 17TH SEPTEMBER 1907.)

NEW FOREST (SWINE-FEVER) ORDER OF 1907.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Restriction on Movement of Swine into or out of the New Forest.

1. From and after the commencement of this Order, swine shall not be moved into or out of the perambulation of the New Forest, in the administrative county of Southampton (herein-after referred to as "the scheduled area"), except in accordance with the provisions of this Order.

Provision for Movement into Scheduled Area with Licence.

2.—(1.) Swine may be moved into the scheduled area if accompanied by a licence authorising such movement, granted by an Inspector of the Local Authority of the administrative county of Southampton, or by the Clerk to the Verderers of the New Forest or a Forest Keeper or Agister authorised to act in this behalf by the said Clerk.

(2.) Before a licence is granted under this Article, the owner of the swine, or his agent authorised in writing for this purpose, shall sign, and deliver or send by post to the Inspector, or other authorised Officer, a declaration, countersigned as hereinafter provided, to the

(i.) That he is the owner of [or the agent authorised in writing for this purpose by

the owner of] the swine;

(ii.) That the swine have been on the premises from which they are to be moved for a period of at least twenty-eight days immediately before the date of the declaration;

(iii.) That to the best of his knowledge and belief the swine are not affected with swinefever, and have not during the period of twenty-eight days as aforesaid been in any way exposed to the infection of swinefever; and

(iv.) That the swine are not in a Swine-Fever Infected Place, and that the movement of the swine is not prohibited by notice of an Inspector of a Local Authority or of the Board given under any Order of the Board.

(3.) The declaration as to swine to be moved shall not be effective until it is countersigned by a police officer of the district where the swine are, who, before countersigning the declaration, shall, so far as is practicable, satisfy himself as to the correctness of the statements contained therein.

(4.) The declaration shall be retained by the Inspector or other authorised Officer granting the

licence thereon.

(5.) The licence shall be in force for six days, inclusive of the day of issue, and shall specify the name and address of the person to whom the licence is granted, the number of the swine to be moved, and the name or description of the place from which, and the place and premises to which, the swine are to be moved.

Provision for Movement of Swine out of Scheduled

3.—(1.) Swine may be moved out of the scheduled area if accompanied by a licence authorising such movement granted by the Clerk to the Verderers of the New Forest or a Forest Keeper or Agister authorised to act in this behalf by the said Clerk, which licence shall be granted only upon production of a declaration similar in terms to that referred to in Article 2 (2) of this Order, except that in the case of swine to be moved to a bacon factory or slaughterhouse a period of ten days may be inserted in the declaration instead of twenty-eight days.

(2.) Swine moved with a licence under this Article shall be moved to the place of destination specified in the licence and not elsewhere and shall be there detained and isolated from other swine for twenty-eight days, unless they are slaughtered on such premises before the expiration of that period. During the movement the swine shall so far as is practicable be kept separate from all swine not being moved with a licence under this Article.

Provision for Movement through Scheduled Area by Road.

4. Swine shall not be deemed to be moved into or out of the scheduled area in any case where they are moved through the area in a float van or cart from a place outside the area to another place outside the area in accordance with the following conditions:-

(1.) The swine must be accompanied by a licence authorising the movement granted by an Inspector of the Local Authority of the administrative county of Southampton; and

(2.) the swine must not within the area be removed from the float van or cart, or be permitted to come in contact with other swine.

(3.) The swine must be moved by the nearest available route and without unnecessary delay.

Provision for Movement through Scheduled Area by Railway.

5. For the purposes of this Order, swine shall not be deemed to be moved into or out of the scheduled area in any case where they are moved through the scheduled area by railway from a place outside the scheduled area to another place outside the scheduled area without unnecessary delay and without the swine being untrucked within the scheduled area.

### General Provision as to Licences.

6.—(1.) A copy of every licence granted under this Order by an Inspector of the Local Authority shall forthwith be delivered up or sent by post to the Clerk to the Verderers of the New Forest at Romsey, and a copy of every licence granted by the said Clerk or by some person authorised by him shall be delivered up or sent by post to the Police Station in the same district nearest to the premises to which the swine are to be moved.

(2.) Where swine are moved with a licence under this Order to any premises outside the scheduled area, the licence shall forthwith after completion of the movement be delivered up at, or sent by post to, the nearest Police Station in the same district by the person in charge of the swine at the time of completing the said movement.

### General Provisions as to Movement.

7.—(1.) Swine, while being moved under this Order, shall so far as is practicable be kept separate from all other swine, and shall be moved by the nearest available route and without unnecessary delay to the place of destination specified in the licence, and not elsewhere.

(2.) This Order does not authorise movement of swine in a Swine-Fever Infected Place or Swine-Fever Infected Area, or of swine the movement of which is prohibited or regulated by any other Order of the Board or by notice of an Inspector of a Local Authority or of the Board given under any such Order.

# Production of Licences; Names and Addresses.

8.—(1.) Any person in charge of a pig being moved, where under this Order a licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, or other authorised person, produce and show to him the licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

# Local Authority to enforce Order.

9. The provisions of this Order shall be executed and enforced by the Local Authority.

### Offences.

10.—(1.) If a pig is moved in contravention of this Order, the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2.) If a person in charge of a pig being moved, where under this Order a licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence

against the Act of 1894.

(3.) If any person fail to deliver up or send a licence, as required by this Order, he shall be deemed guilty of an offence against the Act of 1894.

(4.) If a pig is not isolated as required by this Order, the owner of the pig, and the person for the time being in charge thereof, and the occupier of the place where the pig is detained, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

### Interpretation.

11. In this Order, unless the context otherwise requires-

"Bacon factory" means premises in which the business of a curer of bacon is carried on:

- "Slaughterhouse" means any premises where
- animals are habitually slaughtered:
  "Inspector" includes Veterinary Inspector:
  "The Board" means the Board of Agriculture

and Fisheries : "The Act of 1894" means the Diseases of Animals Act, 1894.

Withdrawal of Swine-Fever (Regulation of Movement Order of 1903 from Scheduled Area.

12. From and after the commencement of this Order the provisions of the Swine-Fever (Regulation of Movement) Order of 1903 shall cease to apply to the scheduled area and swine which are accompanied by a licence under this Order shall not be deemed to be moved into the administrative county of Southampton for the purposes of that Order.

#### Commencement.

13. This Order shall come into operation on twenty-fifth day of September, nineteen hundred and seven.

#### Short Title.

14. This Order may be cited as the New FOREST (SWINE-FEVER) ORDER OF 1907.

Notwithstanding anything contained in the Swine-Fever (Infected Areas) Order of 1902, and the Order of the Board dated the twenty-fourth day of April, 1907, an exhibition and sale of fat swine may be held at the premises and on the date mentioned in the Schedule hereto, on the following conditions :-

(i.) The swine must be moved to the exhibition with a Licence under the Swine-Fever (Infected Areas) Order of 1902, which Licence shall be delivered up at the entrance to the sale by the person in charge of the swine to a person appointed by the Local Authority to receive the same.

(ii.) For the purpose of obtaining the Licence a declaration in the Form set forth in the Schedule to the Somersetshire (Swine-Fever)

Order of 1907, with the necessary modifitions shall be sufficient.

(iii.) The swine exposed at the exhibition may be moved from the exhibition along over or across a highway or thoroughfare in the administrative county of Somerset or the county borough of Bath to any bacon factory or slaughter-house specified in the Licence if accompanied by a Licence authorising such movement-in the Form set forth in the Schedule to the Swine-Fever (Infected Areas) Order of 1902 or to the like effect-granted by the Local Authority of the said county or county borough.

(iv.) The swine shall before being moved from the exhibition be marked by and at the expense

of the owner by the painting, with an indelible composition of red colour, of a broad line down the back and another broad line across the loins of each of the swine, thus +, each line being not less than nine inches long.

(v.) The Licence shall be in force for not more than four days inclusive of the day of

ssue.

(vi.) The swine shall be moved by the nearest available route and without unnecessary

delay.

(vii.) The Licence under this Order for the movement of swine from the exhibition to a bacon factory or slaughter-house shall forthwith after completion of the movement be delivered up at, or sent by post to, the nearest Police Station by the person in charge of the swine at the time of completing the said movement.

(viii.) The swine shall be detained at the bacon factory or slaughter-house and there slaughtered within five days after their

arrival at such premises.

Attendance at Exhibition of Veterinary Inspector.

2. A Veterinary Inspector of the Local Authority shall attend at the exhibition authorised under this Order.

Production of Licences; Names and Addresses.

3.—(1.) Any person in charge of a pig being moved, where under this Order a Movement Licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the Licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

Local Authority to enforce Order.

4. The provisions of this Order shall be executed and enforced by the Local Authority.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

### PART I.

Contraction of application of Hampshire (Swine-Fever) Order of 1907.

1. From and after the commencement of this Order the provisions of the Hampshire (Swine-Fever) Order of 1907 shall apply only to the Area described in the First Schedule hereto, which is hereby declared to be a Swine-Fever Infected Area for the purposes of that Order.

### PART II.

Regulation of Movement of Swine from Markets and Saleyards in parts of Hampshire.

2.—(1.) The movement of swine from any market or saleyard in the Area described in the Second Schedule hereto shall be subject to the

following provisions of this Order.

(2.) If the market or saleyard is specially authorised by the Local Authority under the Swine-Fever (Regulation of Movement) Order of 1903, or under the Swine-Fever (Movement from Ireland) Order of 1904, the movement of the swine exposed at the market or saleyard shall be subject to the provisions of the Order under which the market or saleyard is so authorised.

(3.) In the case of any other market or saleyard, the movement of the swine exposed thereat shall be subject to the following

conditions:-

- (i.) The swine shall be accompanied by a licence granted by an Inspector of the Local Authority of the District in which the market or saleyard is situate. The licence shall state the name and address of the person who moved the swine into the market or saleyard, and the number and description of the swine to be moved, and shall contain a description of the market or saleyard from which, and of the premises to which, the swine are to be moved.
- (ii.) The swine shall be moved to the place of destination specified in the licence and not elsewhere and shall be there detained and isolated from other swine for twentyeight days, unless they are slaughtered on such premises before the expiration of that period. During the movement the swine shall so far as is practicable be kept separate from all swine not being moved with a licence under this Article.
- (iii.) A copy of a licence granted under this Article shall be sent by the Inspector granting the same to the Local Authority of the District in which is situate the place of destination specified in the licence.
- (iv.) After completion of the movement the licence shall forthwith be delivered up at, or sent'by post to, the nearest police-station

in the same District by the person in charge of the swine at the time of completing such movement.

Exhibitions of Swine by Licence of Local Authority.

3.—(1.) An exhibition of swine may be held in the Area described in the Second Schedule hereto with a licence of the Local Authority, on such conditions, if any, as they think expedient, and not otherwise.

(2.) The Local Authority may, if they think fit, by such licence authorise the sale at such exhibition of the swine exhibited thereat on such conditions, if any, as they think expedient.

conditions, if any, as they think expedient.
(3.) The Local Authority shall not grant a licence for an exhibition under this Article unless they are satisfied that the proposed exhibition is a bona fide agricultural show, and that the swine are to be exhibited thereat for competition.

# Production of Licences; Names and Addresses.

4.—(1.) Any person in charge of a pig being moved, where under this Order a licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other

officer.

Local Authority to enforce Order.

5. The provisions of this Order shall be executed and enforced by the Local Authority.

### Offences.

6. If a pig is moved in contravention of this Order, the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and the consignee or other person receiving or keeping it knowing it to have been

moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

### Commencement.

7. This Order shall come into operation on the twenty-fifth day of September, nineteen hundred and seven.

### Short Title.

8. This Order may be cited as the Hampshire (Swine-Fever) Order of 1907 (No. 2).
