

in the same District by the person in charge of the swine at the time of completing such movement.

Exhibitions of Swine by Licence of Local Authority.

3.—(1.) An exhibition of swine may be held in the Area described in the Second Schedule hereto with a licence of the Local Authority, on such conditions, if any, as they think expedient, and not otherwise.

(2.) The Local Authority may, if they think fit, by such licence authorise the sale at such exhibition of the swine exhibited thereat on such conditions, if any, as they think expedient.

(3.) The Local Authority shall not grant a licence for an exhibition under this Article unless they are satisfied that the proposed exhibition is a bonâ fide agricultural show, and that the swine are to be exhibited thereat for competition.

Production of Licences; Names and Addresses.

4.—(1.) Any person in charge of a pig being moved, where under this Order a licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

Local Authority to enforce Order.

5. The provisions of this Order shall be executed and enforced by the Local Authority.

Offences.

6. If a pig is moved in contravention of this Order, the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and the consignee or other person receiving or keeping it knowing it to have been

moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Commencement.

7. This Order shall come into operation on the twenty-fifth day of September, nineteen hundred and seven.

Short Title.

8. This Order may be cited as the HAMPSHIRE (SWINE-FEVER) ORDER OF 1907 (No. 2).

FIRST SCHEDULE.

Swine-Fever Infected Area declared by this Order.

An Area comprising that part of the administrative county of Southampton which is included in the petty sessional division of Odiham.

SECOND SCHEDULE.

Area in which Movement from Markets is regulated by this Order.

An Area comprising the administrative county of Southampton (except the petty sessional division of Odiham and the perambulation of the New Forest); and also comprising the county boroughs of Bournemouth, Portsmouth, and Southampton.
