officers and servants, and to impose penalties for the breach or non-observance of any such bye-laws, rules and regulations, and of any provisions of the Order, and to appoint and remove pier-masters, toll-takers and other officers and servants, and to define the limits within which the powers of such pier-masters, toll-takers, officers and servants may be exercised.

10. To close the proposed pier on special occasions, and to make such special and increased charges on those occasions as they may think fit.

11. To vary or extinguish all or any other rights and privileges which would or might interfere with the objects of the Order, and to confer other rights and privileges.

12. To amalgamate (if and when incorporated) with or to sell, lease or let the whole or any part of the undertaking or the tolls, rates, rents and charges to be levied and charged in respect thereof to any other company, body or person or to purchase or take on lease the undertaking of any other company, body or person, or to sell the same, and to confer upon such companies respectively all necessary powers in that behalf, and to enable the amalgamated company or the lessees or the purchasers, as the case may be, to exercise all or any of the powers of the companies so amalgamated, or of the lessors or vendors as the case may be.
