LIGHT RAILWAYS ACT, 1896.

Portmadoc, Beddgelert and South Snowdon Railway (Light Railway) Order.

The Light Railway Commissioners have resubmitted to the Board of Trade for confirmation, under the above-mentioned Act an Order (being a consolidation with certain modifications of two Orders previously submitted by them) authorising the Portmadoc, Beddgelert and South Snowdon Railway Company to reconstruct, construct, and work the railways authorised by the Portmadoc, Beddgelert and South Snowdon Railway Acts, 1901 and 1904, as a light railway under the Light Railways Act, 1896, and authorising the construction of a light railway in the county of Carnarvon from the termination of the railway authorised by the said Act of 1901 near Bedd-gelert to Bettws-y-Coed, and amending and consolidating the capital and borrowing powers of the Company and for other purposes.

Any objections to the confirmation of the Order so far as they relate to the aforesaid modifications should be addressed to the Assistant Secretary (Railway Department), Board of Trade, Whitehall Gardens, London, S.W., and must be lodged with the Board on or before the 24th December, 1907. To Harry Victor Campbell Roe, District Auditor :-

To Douglass Horace Boggis-Rolfe, Barristerat-Law, District Auditor ;-

To the Guardians of the Poor of the Orsett Union ;-

And to all others whom it may concern.

Whereas by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas by an Order dated the 11th day of August, 1906, We, the Local Government Board, certified the appointment of Harry Victor Campbell Roe as a District Auditor, and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in the said Order was termed "The Cambridgeshire Audit District";

And whereas by an Order dated the 28th day of July, 1904, We certified the appointment of I cent. which will be given for the amounts applied

Douglass Horace Boggis-Rolfe, Barrister-at-Law, as a District Auditor and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in that Order was termed "The Essex Audit District," and it was directed that the said District should, until We otherwise prescribed, comprise, among other areas, the Orsett Union;

And whereas it is desirable that the duty of auditing the Accounts of the Authorities comprised in the area included in the Orsett Union and of their Officers for the half-years ended in March and September, 1907, or for the year ended in March, 1907, as the case may be, should be assigned to the said Harry Victor Campbell Roe:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order and Prescribe as follows:

ARTICLE I.—It shall be the duty of the said Harry Victor Campbell Roe to audit the Accounts of the following Authorities and of their Officers for the half-years ended in March and September, 1907, or for the year ended in March, 1907, as the case may be; namely,-

- (1.) The Guardians of the Poor of the Orsett Poor Law Union.
- (2.) The Overseers of the Poor of the several parishes comprised in the said Union.
- (3.) The Parish Councils and the Parish Meetings of the several parishes comprised in the said Union.
 - (4.) The Orsett Joint Hospital Board.
 - (5.) The Rural District Council of Orsett.
- (6.) The Urban District Council of Grays Thurrock.

ARTICLE II.—The said Harry Victor Campbell Roe shall audit the said Accounts for the said periods in conformity with the provisions contained in Article II of the said Order, dated the eleventh day of August, one thousand nine hundred and six, and for the purposes of the said audits the said Orsett Union shall be deemed to be within the Cambridgeshire Audit District.
