The provisions of the Swine-Fever (Infected Areas) Order of 1902 have been applied to:—

Kent.—An Area comprising the parishes of Cranbrook, Goudhurst, Horsmonden, Marden, Staplehurst, Frittenden, and Headcorn, in the administrative county of Kent (17 January, 1908).

The provisions of the Swine-Fever (Infected Areas) Order of 1902 with modifications have been applied to:—

Berkshire.—(1) An Area comprising the petty sessional division of Abingdon, and the borough of Abingdon, in the administrative county of Berks (11 November, 1907).

(2) An Area comprising the petty sessional division of Maidenhead (except the parishes of Winkfield and Remenham) and the borough of Maidenhead in the administrative county of Berks (16 December, 1907).

Isle of Wight.—An Area comprising the administrative county of the Isle of Wight (17 January, 1908).

Kent.—(1.) An Area in the administrative county of Kent comprising the petty sessional division of Sittingbourne (except the detached portion thereof and the Isle of Sheppey) (4 December, 1907).

(2) An Area in the administrative county of Kent comprising the petty sessional divi-

sions of Wingham, Deal (including its detached part), Ramsgate, and Thanet, and the parish of Sarre; and the boroughs of Deal, Dover, Margate, Ramsgate, and Sandwich (14 August, 1907).

Lincolnshire (Holland).—An Area comprising the administrative county of the Parts of Holland Division of Lincolnshire (except the petty sessional division of Kirton and Skirbeck, and the borough of Boston) (24 January, 1908).

Sussex.—An Area comprising the parishes of Portslade-by-Sea, Portslade, Hangleton, West Blatchington, Patcham, Preston Rural, Stanmer, Falmer (including its detached part), Rottingdean, and Ovingdean, and the borough of Hove, in the administrative county of East Sussex; and also comprising the county borough of Brighton (6 March, 1907).
