The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz.:—

SPECIAL REGULATIONS (supplementary to the General Regulations respecting Open Competitive Examinations for situations in the Civil Service included in Schedule A of the Order in Council of 4th June, 1870), respecting Open Competitive Examinations for the following group of situations, viz.:—

- (I) Junior Appointments in the Supply and Accounting Departments of the Admiralty;
- (II) Junior Appointments in the Royal Ordnance Factories of the War Office;
- (III) The Situation of Second Class Assistant Accountant in the Army Accounts Department;
- (IV) The Situation of Examiner in the Exchequer and Audit Department;
- (V) Appointments as Second Class Clerk in the Estate Duty Office of the Inland Revenue Department;
- (VI) Appointments as Junior Clerk in the Ecclesiastical Commission.

N.B.—These Regulations are liable to alteration for future Examinations.

1. The limits of age for these situations are 18 and 19½, the half-year being reckoned by calendar months. If an Examination commences in one of the first seven months of any year, Candidates must be of the prescribed age on the 1st of May of that year.
