ward along the middle of the said line of railway for a distance of fifty-five chains or thereabouts to the point on the southern side of Wellfieldroad, where such line of railway enters a tunnel, upon the boundary which divides the said parish of Streatham from the said new parish of Saint Peter, Streatham, and extending thence southeastward and in a straight line for a distance of one chain and a half or thereabouts to the southwestern corner of the house and premises known as number 92, Wellfield-road, and extending thence first eastward and then south-eastward along the wall or fence forming the boundary between the houses and premises on the southern side of Wellfield - road, and the houses and premises on the northern side of Gleneldon-road for a distance of thirteen chains and a quarter or thereabouts to the south-eastern end of the said wall or fence on the western side of Valley-road and extending thence first south-eastward to and then south-westward along the middle of Valleyroad for a distance of twenty-one chains or thereabouts to a point opposite to the wall or fence forming the northern boundary of the house and premises known as Emmanuel Vicarage, and extending thence westward to and along the last mentioned wall or fence (thereby crossing the boundary which divides the said new parish of Saint Peter, Streatham, from the said parish of Streatham) for a distance of two chains and a half or thereabouts to its western end on the eastern side of Hopton-road, and extending thence south-westward in a straight obliquely across Hopton-road for a distance of twenty-five yards or thereabouts to the eastern end of the wall or fence forming the southern boundary of the house and premises known as 'The Laurels,' number 1, Polworth-road, and extending thence first westward, then northward and then again westward along the walls or fences forming the southern boundaries of the houses and premises on the southern side of Polworth-road, for a distance of eleven chains · or thereabouts to a point on the eastern side of the private roadway leading from Rutford-road to the north side of Streatham Common, and extending thence south-westward in a straight line across such roadway and across the grounds attached to the houses known as 'Coventry Hall' and 'The Chimes,' for a distance of ten chains or thereabouts to the junction of Streatham Highroad with Natal-road, upon the boundary which divides the said parish of Streatham from the said new parish of Emmanuel, Streatham, and extending thence first south-westward then north-westward along the last mentioned boundary (thereby following the middle of Natal-road, and the middle of Potters-lane) for a distance of twenty-three chains and a quarter or thereabouts to the centre of the bridge which carries the South London, Sutton, and Peckham Line of the London, Brighton, and South Coast Railway across Potters-lane, at which point the said imaginary line commenced."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Southwark.

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the nineteenth day of December, in the year one thousand nine hundred and seven, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Donat, situate at Abercynon, within the parish of Llanwonno, in the county of Glamorgan, and in the diocese of Llandaff.

"Whereas at certain extremities of the said parish of Llanwonno and of the parish of Llanfabon, in the said county and diocese, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Llandonno and of the said parish of Llandahon should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Donat situate at Abercynon as aforesaid.

"Now, therefore, with the consent of the Right Reverend Joshua Pritchard, Bishop of Llandaff, as such Bishop, with the consent of the Reverend David Thomas Griffiths, Clerk in Holy Orders, Vicar or Incumbent of the vicarage of the parish of Llantrisant, in the said county and diocese, and as such Vicar or Incumbent, the Patron of the vicarage of the said parish of Llanwonno, and with the consent of the Dean and Chapter of the cathedral church of Llandaff as the Patrons of the rectory of the said parish of Llanfabon (in testimouy whereof they the said Joshua Pritchard, Bishop of Llandaff, and the said David Thomas Griffiths have respectively signed and sealed this representation and the said Dean and Chapter have caused their common or capitular seal to be affixed hereto), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Llanwonno and of the said parish of Lianfabon which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed
