ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated March 10th, 1908.)

WHEREAS by the 21st Section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts:—

1. And whereas it is expedient, with a view to make the Registration Districts of Hackney and Edmonton co-extensive with the Poor Law Unions of the same names as altered by Local Government Board Order, dated 15th May last (No. P. 2120), which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 13) Act, 1907, and will take effect on the 1st of April next, that the following areas, colured as stated on the Maps sealed with the seal of the Local Government Board, should be transferred as set forth hereunder, viz.:—

Now, therefore, I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This order shall come into operation on the 1st day of April, nineteen hundred and eight.
