WHEREAS His Majesty was pleased, by His Commission dated the seventeenth day of March, one thousand nine hundred and eight, to nominate and appoint His Royal Highness The Prince of Wales, in His Majesty's absence from His Realm in foreign parts, to hold on His Majesty's behalf, His Privy Council, and to signify thereat His approval of any matter or thing whereunto His Royal Highness should be so authorized by writing under His Majesty's Sign Manual, and to do further on His Majesty's behalf any matter or thing for the purposes of the said Commission whereunto His Royal Highness should be authorized in manner aforesaid :

And whereas the Honourable Artillery Company was incorporated by a charter granted by His Majesty King Henry the Eighth, dated the twenty-fifth day of August, fifteen hundred and thirty-seven :

And whereas under divers Royal warrants, letters patent, and Orders in Council, the members of the Company enjoy various civil rights and privileges :

And whereas the Company is possessed of certain land and premises situate in the metropolitan borough of Finsbury, which land and premises are held under two leases, the one

being dated the thirtieth day of December eighteen hundred and fifty-eight, and made between the Commissioners of Lieutenancy for the city of London of the one part, and the persons therein named of the other part, as trustees of the Company, and the other being dated the twenty-third day of June, eighteen hundred and ninety-eight, and made between the mayor and commonalty and citizens of the city of London of the one part, and the persons named therein of the other part, as trustees of the Company :

And whereas it is provided by each such lease that the piece or parcel of land thereby demised shall not be enjoyed for any other use or purpose whatsoever than for the Company to exercise arms in and for the mustering, training, and exercising of the trained bands or militia of the City, in accordance with certain provisions in the said leases respectively contained :

And whereas the existing trustees by whom the said land and premises comprised in the said leases are held are Captain Edward Blanks, Lieutenant-Colonel George Thomas Carpenter, Captain William Elam, Thomas Lampard Green, and William Harrison Hillman :

And whereas by an Order in Council made under section twenty-nine of the Territorial and Reserve Forces Act, 1907, dated the nineteenth day of March, nineteen hundred and eight, the Company has become a unit of the Territorial Force by the title of the Honourable Artillery Company, and is comprised in the part of that force under the administration of the Territorial Force Association for the City of London.
