

Act, 1905, and the South Eastern and London, Chatham and Dover Railway Companies Act, 1900, viz. :—

(a) Victory Bridge.

(b) Ravensbourne-street Railway Bridge.

Purchase of property, compensation, works and other incidental expenditure in connection with the reconstruction of Catford Bridge under the London County Council (General Powers) Act, 1906.

Purchase of property, compensation and works, and other incidental expenditure in connection with street improvements under the London County Council (Tramways and Improvements) Act, 1906, viz. :—

(a) Mitcham-road widening.

(b) Falcon-road, Battersea, widening.

(c) York-road, Wandsworth, widening.

Reconstruction of Necker Bridge, Deptford, under the London County Council (General Powers) Act, 1907.

Purchase of property, compensation, works and other incidental expenditure in connection with the reconstruction of tramways under the London County Council (Tramways and Improvements) Act, 1907.

Building, enlarging and improving lunatic asylums, preparation of plans for further asylum accommodation, buildings (including alterations and additions to buildings), fittings, furniture, equipment, heating, lighting, drainage, fencing, machinery, &c., purchase of a site for a hospital for the insane or mentally afflicted, and expenditure for the equipment thereof, and miscellaneous expenditure in connection with the various asylums and on purchase, improvement and development of lands held therewith.

Acquisition of site for, and incidental expenditure in connection with the erection of a County Hall under the Local Government Act, 1888, and the County Office Site (London) Act, 1906.

Expenditure under the Education Acts, 1870 to 1903, including the provision of schools, erection of stores and other purposes of those Acts.

Purchase of tramways, reconstruction and equipment of tramways for electrical traction, including power stations, plant and machinery, rolling-stock, car sheds and other like matters, purchase of lands and erection of new or alteration and enlargement of existing buildings, construction of a tramway subway between the Strand and the Victoria Embankment, construction of new tramways and extensions, junctions and other like works, reconstruction of bridges or other purposes.

Provision of new pumping stations, enlargement of and improvements at existing pumping stations and outfalls, engines, machinery, and other like matters; purchase of property and compensation in connection therewith; new outfall and intercepting sewers and other works.

Financial adjustments under the London Government Act, 1899.

Other purposes authorized by statute but not included above.

The execution of any powers which may be conferred upon the Council by any other Acts of the present Session if their Bills now pending in Parliament or any of them are passed into law, or the Provisional Orders for which they are applying to the Board of Education is granted and confirmed by Parliament, including, amongst

other things, the contribution towards the purchase of lands for an open space, the construction and equipment of tramways, the execution of street improvements and works, purchase of lands and erection of buildings and other purposes in connection with tramways, and for the purposes of the Education Acts, 1870 to 1903.

Generally all other subjects in respect of which capital expenditure is or may be necessary during the financial year commencing 1st April, 1908, and (on account of the next financial year) during the six months ending 30th September, 1909.

To enable the Council from time to time to raise money by the creation and issue of consolidated stock or bills, or by borrowing to such amount as may be necessary for the purposes defined in the intended Act, and to make provisions as to the redemption of such stock or repayment of such bills or loans, and the payment of dividend or interest thereon out of the Consolidated Loans Fund or otherwise, and to include in their estimates and precepts for the purpose of the county rate such sums as may be requisite for those purposes.

To make further provisions as to the redemption or conversion of stock and the purchase of such stock from time to time by the Council with a view to the extinction thereof.

To confer further powers with respect to the Consolidated Loans Fund and the management, investment and use of money standing to the credit of that fund and other moneys of the Council.

To make provisions as to loans by the Council to the councils of the metropolitan boroughs and the city of Westminster, boards of guardians and other local and public authorities.

To make provisions as to loans by the Council to persons under the Small Dwellings Acquisition Act, 1899.

To define and regulate the period within which stock to be hereafter created is to be redeemed or made redeemable, and within which provision is to be made for the replacement in the Consolidated Loans Fund of moneys employed for various purposes of capital expenditure, and to define the method by which such provision is to be made.

To vary and extinguish all rights and privileges which would interfere with the objects of the intended Act, or any of them.

To amend, so far as may be necessary for the purposes of the Bill, the London County Council (Money) Act, 1907, and the Acts therein referred to, and any Acts now in force relative to the matters aforesaid, or any of them.

Printed copies of the proposed Bill will be deposited in the Private Bill Office of the House of Commons, in accordance with the provisions of the Standing Orders, on or before the first day on which that House shall reassemble after the Easter recess.
