published in the London Gazette on the thirtieth day of the same month a district chapelry was assigned to the consecrated church of Saint John the Baptist, Plumstead, and the said district chapelry was named 'The District Chapelry of Saint John the Baptist, Plumstead.'

"And whereas by the authority of an Order of Your Majesty in Council bearing date the eleventh day of June in the year one thousand nine hundred and two and published in the London Gazette on the thirteenth day of the same month a district chapelry was assigned to the consecrated church of Saint Paul, Plumstead, and the said district chapelry was named 'The District Chapelry of Saint Paul, Plumstead.'

"And whereas the said district chapelry of Saint Nicholas, Plumstead, and the said particular district of Saint James, Plumstead, have become new parishes of the character contemplated by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, by the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four.

"And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said new parish of Saint Nicholas, Plumstead, and the said new parish of Saint James, Plumstead, should be altered in the manner which is hereinafter mentioned.

"Now therefore with the consent of the Right Reverend Edward Stuart, Bishop of Southwark (in testimony whereof he has signed and sealed this scheme or representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Saint Nicholas, Plumstead, and the said new parish of Saint James, Plumstead, shall be altered so that (firstly) all those portions of the said parish of Plumstead, which are described in the first schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such parish and shall be annexed to and shall in future form part of the said new parish of Saint James, Plumstead, and (secondly) all that portion of the said new parish of Saint Nicholas, Plumstead, which is described in the second schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said district chapelry of Saint John the Baptist, Plumstead, and (thirdly) all that portion of the said new parish of Saint Nicholas, Plumstead, which is described in the third schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured violet shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said district chapelry of Saint Paul, Plumstead.

"And we further represent, recommend, and propose that nothing herein contained shall prevent us from representing, recommending, and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore in the said county and diocese, and upon the

one thousand eight hundred and eighty-five and | mentioned Acts or any of them or any other Act of Parliament.

> "The SCHEDULES to which the foregoing Scheme or Representation has reference.

> > "THE FIRST SCHEDULE.

"The territory to be annexed to the new parish of Saint James, Plumstead, in the county of Kent, and in the diocese of Southwark, being:-

"I. All that isolated portion of the parish of Plumstead, in the said county and diocese, which is bounded upon the north by the new parish of Holy Trinity, Woolwich, upon the east by the district chapelry of Saint John the Baptist, Plumstead, both in the said county and diocese, upon the south-east by the said new parish of Saint James, Plumstead, and upon the west by the new parish of Saint John, Woolwich, in the said county and diocese.

"II. And also all that portion of the said parish of Plumstead which is bounded upon the west and upon the north by the said new parish of Saint James, Plumstead, and upon the remaining sides, that is to say, upon the northeast, upon the south-east and upon the south, by an imaginary line commencing upon the boundary which divides the said new parish of Saint James, Plumstead, from the said parish of Plumstead, at a point in the middle of Church Passage opposite to the northern end of the fence forming the boundary between the house and premises known as Oaklands, and the house and premises known as the Oaks, and extending thence first southward to the said fence and then first southeastward and then south-westward along the fences forming the north-eastern and southeastern boundaries of the last named house and premises for a distance of nine chains or thereabouts to the point where the fence forming the south-eastern boundary of the said house and premises meets the eastern side of the lane running between such house and premises and the backs of the houses and premises on the eastern side of Burrage-road, and extending thence due west in a straight line across the said lane for a distance of nine yards or thereabouts to the wall forming the southern boundary of the house and premises known as number 239, Burrage-road, and extending thence south-westward along the walls or fences forming the south-eastern boundaries of the houses and premises (including the Wesleyan Methodist Chapel) on the eastern side of Burrage-road for a distance of four chains and a half or there-. abouts to the point where the wall or fence forming the south-eastern boundary of the said chapel meets the northern side of Plumstead Common-road, and extending thence first southward to and then westward along the middle of Plumstead Common-road for a distance of one chain and a half or thereabouts to its junction with Burrage-road upon the boundary which divides the said parish of Plumstead from the said new parish of Saint James, Plumstead.

"THE SECOND SCHEDULE.

"The territory to be dissevered from the new parish of Saint Nicholas, Plumstead, in the said county and diocese, and to be annexed to the said district chapelry of Saint John the Baptist, Plumstead, being :-

"All that part of the isolated portion of the said new parish of Saint Nicholas, Plumstead, which is bounded upon the north by an isolated portion of the said parish of Plumstead, upon the west by the said district chapelry of Saint John the Baptist, Plumstead, upon the south by the consolidated chapelry of Saint Mark, Plumstead,
