

Now, therefore, the Lord Chancellor and the Lord President, being authorized thereto by writing under His Majesty's Sign Manual, do hereby on behalf of His Majesty, give notice of such representation, and order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council on the eighteenth day of May next.

And further, on behalf of His Majesty, do direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said eighteenth day of May.

The following Statutes made by the University of Cambridge have been submitted for the approval of His Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

STATUTES to alter and amend the Statutes framed by the Commissioners appointed under "The Universities of Oxford and Cambridge Act, 1877, 40 and 41 Vict., Cap. 48," in relation to the University of Cambridge, which amending Statutes are now submitted for the approval of His Majesty the King in Council.

We the Chancellor, Masters, and Scholars of the University of Cambridge, in pursuance of the power given to us by the 53rd section of the said Act, do hereby alter the Statute framed by the said Commissioners in relation to our said University in manner following:—

By adding to Chapter VI, Statute B, the following Sections:—

12. Except in cases in which the University shall by Grace determine otherwise, two Professorships in the University shall not be held at the same time by the same person; and upon a Professor's acceptance of a second Professorship, that already held by him shall become, ipso facto, vacant.

13. Except in cases in which the University shall by Grace determine otherwise, the office of Professor shall not be tenable together with that of Reader or that of University Lecturer in the University; and if a person holding any one of these three offices shall accept either of the others, he shall thereby, ipso facto, vacate the one previously held by him.

By repealing the third paragraph of Section 2 of Chapter VII, Statute B, and substituting therefor the following amended paragraph:—

On the occasion of a vacancy in any Readership, a Reader shall be appointed in the subject to which the Readership has been assigned to fill the vacancy, unless within twelve weeks of the vacancy, days of any vacation not being reckoned, on the recommendation of the General Board the Readership is by Grace transferred to another subject or is suppressed.

By repealing the second paragraph of Section 4 of the same Chapter VII, Statute B, and

substituting therefor the following amended paragraph:—

If the General Board and the Special Board do not agree in any appointment within twelve weeks after the vacancy, or within twelve weeks after the transference of the Readership by Grace of the Senate, days of any vacation not being reckoned, the appointment shall be made for that turn by the Council of the Senate.

By adding to Chapter VII of the same Statute B the following paragraphs:—

8. Except in cases in which the University shall by Grace determine otherwise, two Readerships in the University shall not be held at the same time by the same person; and upon a Reader's acceptance of a second Readership, that already held by him shall become, ipso facto, vacant.

9. Except in cases in which the University shall by Grace determine otherwise, the office of Reader shall not be tenable together with that of Professor or that of University Lecturer in the University; and if a person holding any one of these three offices shall accept either of the others, he shall thereby, ipso facto, vacate the one previously held by him.

The following Statute, made by the Governing Body of All Souls College, Oxford, on the twenty-eighth day of February, one thousand nine hundred and eight, and sealed on the third day of March, one thousand nine hundred and eight, amending Statute XIIa, Clause 2, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

To the KING's Most Excellent Majesty in Council.

THE HUMBLE PETITION of the Warden and College of the Souls of All Faithful People deceased of Oxford commonly called All Souls College.

Whereas the University of Oxford Commissioners, under and by virtue of all and every the powers in that behalf enabling them contained in the Universities of Oxford and Cambridge Act, 1877, did by an Instrument under their seal, dated the sixteenth day of June, one thousand eight hundred and eighty-one, make certain Statutes thereunto annexed for your Petitioners who are therein described as "the College of All Souls of the Faithful Departed, commonly called All Souls College, in the University of Oxford."

And whereas such Statutes were approved by Her late Majesty in Council on the third day of May, one thousand eight hundred and eighty-two.
