ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 24th April, 1908.)

Whereas by the twenty-first section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient, in order that the Registration Districts of Norwich and St. Faith's may respectively be made co-extensive with the Poor Law Parish and Poor Law Union of the same names as altered by the Local Government Board's Provisional Order, No. P. 2102, dated 15th May, 1907, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 13) Act, 1907, and came into operation on the 9th November, 1907, that the parts of Norwich civil parish and county borough, previously parts of Catton and Sprowston civil parishes respectively, should be transferred from St. Faith's Sub-District of St. Faith's Registration District to East Wymer Sub-District of Norwich Registration District.

2. Now, therefore, I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on the first day of May, nineteen hundred and eight.

Official notification expected to-morrow."

"Sickness at La Guaira stated to be pernicious fever of the coast sometimes accompanied by swollen glands; all communication with infected area forbidden. As far as ascertainable five new cases yesterday, but no deaths reported."
