Whereas the benefices of Sherborne and Castleton, both in the county of Dorset and diocese of Salisbury, were avoided on the first day of February instant by the retirement under the provisions of the Incumbents' Resignation Acts, 1871 and 1887, of the Reverend William Hector Lyon (hereinafter called the retired Incumbent), and there was assigned to the retired Incumbent out of the revenues of the benefice of Sherborne a yearly pension under the said Resignation Acts of ninety pounds (hereinafter called the said pension), now we, the Ecclesiastical Commissioners for England, acting in accordance with our Regulations dated the thirtieth day of May, one thousand nine hundred and seven, relating to grants in aid of pensions to retired Incumbents (hereinafter called the said Regulations), do hereby grant out of our common fund to the retired Incumbent the yearly sum of fifty pounds to be payable so long only as the said pension shall continue payable out of the revenues of the said benefice of Sherborne, and to be subject as hereinafter mentioned, and to commence and be computed from the said first day of February instant, and to be paid by equal quarterly payments on the first day of February, the first day of May, the first day of August, and the first day of November in every year, subject nevertheless to cesser, determination, withdrawal, suspension or reduction as a grant made in accordance with the said Regulations, and to all other the provisions and conditions contained in the said Regulations and applicable to a grant made in accordance therewith.

In witness whereof, we have hereunto set our common seal, this twenty-seventh day of February, one thousand nine hundred and eight.

No. 596.—CHINA, TONG KING GULF—HAINAN STRAIT.

Hoi Hau Light—Not Shown on Certain Charts.

Particulars.—The undermentioned light in Hoi Hau Bay is not shown on certain copies of Admiralty Chart No. 876.

Position.—Lat. $20^{\circ} 1\frac{1}{2}'$ N., long. $110^{\circ} 16\frac{1}{2}'$ E.

Character.—Red and white group flashing every forty-five seconds as described in the Admiralty List of Lights, Part VI, 1908, No. 760, and as shown on Chart No. 37 Hoi Hau Bay.

Cape St. James, Eastern Approach—Whistle-Buoys Withdrawn.

a. Britto Bank.

Position.—On north-eastern side of bank; lat. $10^{\circ} 29\frac{1}{2}'$ N., long. $107^{\circ} 50\frac{1}{2}'$ E.

Description.—Two conical whistle-buoys painted in black and white bands.

b. Holland Bank.

Position.—On western side of bank; lat. $10^{\circ} 39\frac{1}{2}'$ N., long. $108^{\circ} 40'$ E.

Description.—A white conical whistle-buoy.
