Certain Eggs protected throughout the County.

VI. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the County of Cumberland :

Hedge Accentor (Hedge Sparrow), Reed Bunting, Common Buzzard, Chiffchaff, Corn Crake (or Land Rail), Tree Creeper, Crossbill, Cuckoo, Curlew, Dipper, Dotterel, Turtle Dove, Dunlin, Peregrine Falcon, Pied Flycatcher, Spotted Flycatcher, Goldfinch, Little Grebe, Kestrel, Kingfisher, Linnet, Mallard or Wild Duck, House Martin, Sand Martin, Merlin, Nightjar, Ring Ouzel, Owls, Oyster Catcher, Tree Pipit, Rock Pipit, Golden Plover, Ringed Plover, Quail, Water Rail, Raven, Lesser Red-pole, Redshank, Redstart, Sandpiper, Shoveller, Skylark, Snipe, Tree Sparrow, Stonechat, Swallow, Swift, Teal, Terns, Coal Tit, Great Tit, Long-tailed Tit, Marsh Tit, Twite, Grey Wagtail, White Wagtail, Yellow Wagtail, Blackcap Warbler, Garden Warbler, Grasshopper Warbler, Sedge Warbler, Willow Warbler, Wood Warbler, Wheatear, Whinchat, White-throat, Lesser Whitethroat, Woodpeckers, Wren, Golden-crested Wren, and (between the 15th April and the 1st July in each year) Lapwing, Peewit, or Green Plover.

Repeal of former Order.

VII. The Order of the 12th September, 1907, is hereby repealed.

INCOME TAX.

Whereas by the Taxes Management Act, 1880 (43 and 44 Vict., c. 19), power is given for increasing in certain cases the number of persons appointed, under the provisions made by the Income Tax Act of 1842, Commissioners for the general purposes of the Income Tax, and persons to supply vacancies amongst such Commissioners in each district, or division, in Great Britain; and it appearing to the Board of Inland Revenue that the number of persons so appointed for the division of Kingsbridge, in the county of Wilts, is insufficient for the proper discharge of the business therein arising under the Tax Acts, the said Board hereby authorize the increase in the number of the Commissioners for the said division to any number not exceeding fourteen, and of persons to supply vacancies amongst such Commissioners to any number not exceeding fourteen; and we, the undersigned, two members of the said Board, do hereby convene a meeting of the persons appointed for putting in execution within the said division an Act passed in the 38th year of the reign of King George the Third, intituled "An Act for granting an aid to His Majesty by a Land Tax to be raised in Great Britain for the service of the year 1798," being respectively qualified to act as Commissioners in the execution of the last-mentioned Act, to be holden at the Town Hall, in Swindon,

on Monday, the 1st day of June, 1908, at noon, for the purpose of choosing and appointing, according to the regulations of the said Income Tax Act of 1842, such number of fit and. proper persons to be Commissioners for General Purposes for the said division of Kingsbridge, and of persons to supply vacancies amongst such Commissioners, as may be sufficient to increase the number of such Commissioners to any number not exceeding fourteen, and of persons to supply vacancies amongst such Commissioners to any number not exceeding fourteen.

ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 14th May, 1908.)

Whereas by the twenty-first section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts :-

 And whereas it is expedient, in the interest of public convenience, that Whixall Civil Parish should be transferred from Prees Sub-District of Wem Registration District to Wem Sub-District

of the same Registration District.

2. Now, therefore, I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take reffect accordingly.
