MOTOR CAR ACT, 1903. Regulations under Section 9 (1). COUNTY OF DENBIGH. Urban District of Llanrwst.

To the County Council of Denbigh;-And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public on the application of the Local Authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas We have received and duly considered an application from the County Council of Denbigh for the issue of a Regulation in pursuance of the said sub-section putting the abovementioned provisions of that sub-section in force within the limits comprising certain roads and parts of roads situate within the urban district of Llanrwst, in the county of Denbigh:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our

Order, make the following Regulations:—
ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads and parts of roads within the urban district of Llanrwst which are specified in the Schedule hereto.

ARTICLE IL.—These Regulations shall come into operation on the eighth day of June, one

thousand nine hundred and eight.

SCHEDULE.

So much of the main road to Llandudno and Colwyn Bay as extends from its junction with Station-road to the railway bridge;

So much of Station-road as extends from its junction with the main road aforesaid to its termination at Ancaster-square;
