#### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 18TH AUGUST 1908.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

From and after the twenty-second day of August, nineteen hundred and eight, the provisions of the Sheep-Scab (Compulsory Dipping Areas) Order of 1906 and the Black Mountain District (Sheep Dipping) Order of 1908 shall cease to apply to the Area described in the Schedule hereto, and the provisions of the Sheep-Dipping (South Wales and Monmouth) Order of 1908 shall thereupon apply thereto.

In witness whereof the Board of Agriculture and Fisheries have hereunto set their Official Seal this eighteenth day of August, nineteen hundred and eight.
