ORDER of the Local Government Board; Motor Car Act, 1903. Regulations under Section 9 (1).

COUNTY OF WEST SUSSEX. CRAWLEY AND IFIELD PARISHES. To the County Council of West Sussex :-And to all others whom it may concern.

Whereas by Sub-section (1) of Section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view

to the safety of the public on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles

per hour;

And whereas the County Council of West Sussex, having made application to Us to make a Regulation in pursuance of the said Subsection putting the above-mentioned provisions of that Sub-section in force within the limits comprising parts of certain roads situate within the Parishes of Crawley and Ifield, in the County of West Sussex, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:-

ARTICLE I.—The provisions of Sub-section (1) of Section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the parts of roads within the said Parishes which are specified in the Schedule hereto.

ARTICLE II.—These Regulations shall come into operation on the thirty-first day of August,

one thousand nine hundred and eight.

SCHEDULE.

So much of the main road from London to Brighton (including High-street) as extends from its junction with Black Dog-lane to the southern boundary of the Parish of Ifield;

So much of the main road from Crawley to Horsham as extends from its junction with High-street to a point in the main road situate ten yards south of its junction with Springfieldroad.
