The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of Circulars issued by the Bulgarian Government declaring the town of Tashkend, the governments of Poltava, Samara and Simbirsk, the provinces of Kouban, the district of Nikolaevsk, the towns of Kertch and Yenikale, and the city of St. Petersburg to be infected with cholera.

A further Circular states that the Bulgarian Government has ordered that travellers coming from contaminated places in Russia, who have made a journey of 7 days up to their arrival in Bulgaria will be submitted to a strict medical visit, a disinfection of their clothes and baggage, and also to a surveillance of 5 days at their homes or stopping places.
