PARISH OF FULHAM.

To the Guardians of the Poor of the Parish of Fulham;-

And to all others whom it may concern.

Whereas by a General Order dated the 14th day of December, 1852, which is in force in the Parish of Fulham, the Poor Law Board prescribed Regulations with regard to the administration of out-door relief to poor persons :--

And whereas it is expedient that further provision should be made temporarily with regard to the administration of relief to certain classes of poor persons in the said Parish:
