

26. To enable the Corporation to enter into and fulfil agreements for the supply of electric energy in bulk or otherwise to the local authorities, companies or persons outside the district and particularly to empower the Corporation to supply energy to any consumer whose premises are within such distance as the Bill may prescribe of any electric mains or cable of the Corporation.

27. To make further provision for the better carrying on of the electric undertaking of the Corporation.

28. To empower the Corporation to raise money by the issue of stock, or by mortgage or otherwise, for the purposes of the Bill, and to enable the Corporation to charge the moneys so borrowed on the borough fund and borough rate and on the district fund and general district rate and upon the rates and revenues to arise under the Bill or other properties, funds, rates and revenues of or under the control of the Corporation or on any of the properties, funds, rates and revenues aforesaid as they may determine.

29. To empower the Corporation to invest their sinking funds in the rates or other securities of any corporation, including those of the Corporation, and to include in all mortgages granted by the Corporation, as security for moneys borrowed by them, the corporate estate and all properties and undertakings and the rents and profits thereof.

30. To enable the Corporation to use moneys standing to the credit of any of their sinking funds, instead of borrowing, to prescribe the use of one form of mortgage for all purposes, and to employ accountants as auditors in addition to or in substitution for the borough auditors.

31. To incorporate, with alterations and amendments, and to apply, amend, alter or repeal all or some of the provisions of the several Acts of Parliament following, or some of them (that is to say):—The Lands Clauses Acts; the Local Loans Act, 1875; the Public Health Acts, and all Acts amending the said Acts respectively, or any of them.

32. To alter, amend, extend, enlarge or repeal or re-enact with or without amendment, all or some of the provisions of the Shrewsbury Improvement Act, 1855, and any other Acts and Orders relating to the Corporation, the Severn Navigation Act, 1890, and any other Act or Order relating to the Severn Navigation or the Severn River Towing Paths.

And notice is hereby also given that on or before the 30th November, 1908, plans and sections of the works intended to be authorized by the Bill showing the lines and levels thereof, and showing the lands intended to be taken compulsorily under the powers of the Bill, with a book of reference to such plans and a copy of this Notice as published in the London Gazette will be deposited for public inspection with the Clerk of the Peace for the county of Salop at his office at Shrewsbury and with the Town Clerk at his office at Shrewsbury, and a copy of so much of the said plans and book of reference as relates to the parish of Meole Brace in which any lands, houses or other property intended to be taken are situate, together with a copy of this Notice, will on or before the same date be deposited with the Clerk to the Rural District Council of Atcham, at his office at Shrewsbury, and with the Clerk to the Parish Council of Meole Brace, at his residence, or if there be no clerk to such council, with the Chairman of the Council at his residence.

Printed copies of the intended Act will be deposited in the Private Bill Office of the House of Commons on or before the 17th December, 1908.

HEYWOOD CORPORATION.

(Conferring further Powers on the Corporation of Heywood; Increasing the Number of the Council; Altering and Increasing Wards; Compulsory Running Powers over certain Tramways of the Corporations of Bury and Rochdale, making Junctions therewith; Provisions as to through Booking, Interchange of Traffic and Apportionment of Tolls, Rates and Charges; Agreements; further Provisions concerning the Gas and Electricity Undertakings of the Corporation; Gas Testing; Electricity Station; Free Wiring; Supply in Bulk; New Streets and Buildings; Sewers; Infectious Disease and Sanitary Provisions; Advertising; Bye-laws; Exclusion of Borough from Salford Hundred Court of Record; Borrowing Powers; Redemption of Annuities; Subscriptions; Incorporation, Amendment and Repeal of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Mayor, Aldermen and Burgesses of the borough of Heywood (in this Notice referred to as "the Corporation") for leave to bring in a Bill for all or some of the following purposes (namely):—

1. To divide the borough of Heywood (in this Notice referred to as "the borough") into an increased number of wards and to alter the boundaries of the existing wards or some of them.

2. To increase the number of aldermen and councillors of the borough and to apportion the existing and new councillors to and among the new or altered wards, and to provide for the election, going out of office and rotation of the additional aldermen and councillors and to make provision in the Bill for the doing and determining of the matters aforesaid or any of them and of any other matters necessary or incidental thereto.

3. To enlarge the powers of the Corporation in regard to the construction and maintenance of a new road between Heywood and Middleton and to amend section 13 of the Heywood Corporation Act, 1889, in reference thereto.

4. To empower the Corporation and any company, local authority or other body or persons running over and using the tramways of the Corporation or any part thereof to run over and use with their engines and carriages for the purposes of passenger, goods and other traffic and with their officers and servants upon such terms and conditions and upon payment of such tolls, rates and charges or other consideration as may be agreed upon or as, failing agreement, may be
