# MOTOR CAR ACT, 1903.

## County of Denbigh.

Love-lane and Highgate;

So much of Nantglyn-road as extends from top of Love-lane to Lawnt;

Bridge-street; Lenton Pool; Smithfield-road; Lôn Llewelyn; Henllan-street;

So much of Gwaenynog-road as extends from its junction with Henllan-street to its junction with Lon Llewelyn;

So much of Henlian-road as extends from its

junction with Henllan-street to Coppy; So much of Henllan-road as extends from Chweffordd to Denbigh-street, Henllan;

Denbigh-street and Llindir-street, Henllan, to the borough boundary by Pandy;

Church-street, School-street, and Ty Coch-

street, Henllan;

Mill-road, extending from its junction with Church-street, Henllan to Henllan Mill; and

Garn-road, extending from its junction with School-street, Henllan, to Bryn-y-garn.
