W information in the international sector is a sector of the sixteenth and seventeenth years of the Act of the sixteenth and seventeenth years of Her late Majesty Queen Victoria, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and twenty-four, duly prepared and laid before His Majesty in Council a scheme bearing date the third day of December, in the year one thousand nine hundred and eight, in the words and figures following, that is to say: —

 and twenty-four, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of Kirklington, situate in the county of Nöttingham and in the diocese of Southwell, for the patronage of the benefice (being a rectory) of Hockerton, situate in the said county of Nottingham and in the said diocese of Southwell.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Kirklington is vested in the Bishop of Ripon and his successors.

"And whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Hockerton is vested for an estate in fee simple in possession free from encumbrances in Thomas Craven, of Kirklington Hall in the said county of Nottingham, Esquire.

"And whereas the Right Reverend William Boyd, now Bishop of Ripon, and the said Thomas Craven have respectively signified to us their desire that the patronage of the said two benefices may be rearranged by way of exchange in the manner which is hereinafter recommended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances and relative value of the said two benefices and of the patronage thereof respectively and we do hereby certify to Your Mujesty in Council that the circumstances and present values of the said two benefices are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said William Boyd, Bishop of Ripon, acting as such Bishop (in testimony of which consent he has signed this scheme and caused his episcopal seal to be affixed thereto) and with the
