LIGHT RAILWAYS ACT, 1896.

The Board of Trade have recently confirmed the undermentioned Orders, made by the Light Railway Commissioners:—(1) Bere Alston and Calstock Light Railway (Extension and Amendment) Order, 1909, authorising the construction of a Light Railway in the county of Cornwall, from Kelly Bray to North Hill (being an extension of the Light Railway authorised by the Bere Alston and Calstock Light Railway Orders, 1900 to 1906), and for other purposes; (2) Shropshire and Montgomeryshire Light Railway Order, 1909, authorising the reconstruction and working as a Light Railway of certain parts of the railways and works of the Shropshire Railways Company, in the counties of Shropshire and Montgomeryshire.

ORDER of the Local Government Board:
District Auditors Act, 1879: Assignment of Duties and District (Supplemental):—

CAMBRIDGESHIRE AUDIT DISTRICT.

Billericay Union.

To Harry Victor Campbell Roe, District Auditor;—

To Douglass Horace Boggis-Rolfe, Barrister-at-Law, District Auditor;—

To the Guardians of the Poor of the Billericay Union;—

And to all others whom it may concern.

Whereas by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas by an Order dated the 11th day of August, 1906, We, the Local Government Board, certified the appointment of Harry Victor Campbell Roe as a District Auditor, and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in the said Order was termed the Cambridgeshire Audit District;

And whereas by an Order dated the 28th day of July, 1904, We certified the appointment of Douglass Horace Boggis-Rolfe, Barrister-at-Law, as a District Auditor and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in that Order was termed the Essex Audit District, and it was directed that the said District should, until We otherwise prescribed, comprise, among other areas, the Billericay Union;

And whereas it is desirable that the duty of auditing the Accounts of the Authorities comprised in the area included in the Billericay Union and of their Officers for the half-year ended in September, 1908, should be assigned to the said Harry Victor Campbell Roe:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order and Prescribe as follows:—

ARTICLE I.—It shall be the duty of the said Harry Victor Campbell Roe to audit the Accounts of the following Authorities and of their Officers for the half-year ended in September, 1908, namely,—

- (1.) The Guardians of the Poor of the Billericay Poor Law Union.
- (2.) The Overseers of the Poor of the several parishes comprised in the said Union.
- (3.) The Rural District Council of Billericay.

ARTICLE II.—The said Harry Victor Campbell Roe shall audit the said Accounts for the said period in conformity with the provisions contained in Article II of the said Order, dated the eleventh day of August, one thousand nine hundred and six, and for the purposes of the said audits the said Billericay Union shall be deemed to be within the Cambridgeshire Audit District.
