North-East End Light-Vessel-Replaced by Relief Light-Vessel.

Subject.—On or about the 10th February, 1909, Relief Light-Vessel No. 16, temporarily marking the position of North-east End Light-vessel, would be replaced by a relief light-vessel of the undermentioned description, and exhibiting lights of the character given below.

The number "78" is inscribed in white on each bow and quarter, and "RELIEF' on each side in black.

Fog-signal.—Similar to that of the permanent light-vessel, viz., a steam whistle giving a group of two blasts every two minutes, thus:—Blast, 4 seconds, silent interval, 5 seconds; blast, 4 seconds, silent interval; 107 seconds.
