The following draft Rule is published pursuant to the Rules Publication Act, 1893:—

BANKRUPTCY ACTS, 1883 AND 1890. Draft General Rule made pursuant to Section 127 of the Bankruptcy Act, 1883.

Bankruptcy Notice on County Court Judgment.

1. Where a judgment, on which a creditor desires that a Bankruptcy Notice may be issued, has been obtained in a County Court, the creditor shall with his request for issue of a Bankruptcy

Notice produce to the Registrar a certificate of the judgment instead of an office copy.

Citation and commencement.

This Rule shall be construed as one with the Bankruptcy Rules, 1886 and 1890, and shall come into operation on the making thereof, and may be cited with the said Rules as Rule 137A.
