he has signed and sealed this scheme) and with the consent of the said Edmund Arbuthnott, Bishop of Manchester (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said bene-fice of Christ Church, Ainsworth (otherwise Cockey), now vested in him, the said Thomas Ebenezer Cleworth, as such Rector or Incumbent of the said rectory of Middleton as aforesaid, shall be transferred from him, the said Thomas Ebenezer Cleworth, and from his successors Rectors or Incumbents of the said rectory of Middleton, to the said Edmund Arbuthnott, Bishop of Manchester, and his successors in the same Bishoprick and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edmund Arbuthnott, Bishop of Manchester, and by his successors in the same Bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts, and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned that is to say the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirtynine and the Act of the thirty-first and thirtysecond years of Her said late Majesty, chapter thirtynoe hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the eighteenth day of March, in the year one thousand nine hundred and nine, in the words and figures following, that is to say:--

say:---"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty,

Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Kineton, in the county of Warwick and in the diocese of Worcester.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Kineton is vested for an estate in fee simple without encumbrances in certain trustees upon trust in the first place for the Right Houourable Richard Greville, Baron Willoughby de Broke, of Kineton, in the county of Warwick (hereinafter called the said Lord Willoughby de Broke) during his life and the said Lord Willoughby de Broke is therefore the Patron or person entitled to present or nominate to the said benefice in case the same were now vacant.

"And whereas the said Lord Willoughby de Broke is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Kineton should be transferred in the manner which is hereinafter recommended and proposed.

"And whereas the Right Reverend Huyshe Wolcott, now Bishop of Worcester, in token of his willingness to accept jointly with the other persons hereinafter mentioned the transfer of the said advowson or perpetual right of patronage hereinafter recommended and proposed and in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Kineton which is hereinbefore mentioned and hereinafter recommended and proposed will render the same benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say in the parish of Kineton.

"Now therefore with the consent of the said Lord Willoughby de Broke being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts and of the Act of the first and second years of Her said late Majesty, chapter one hundred and six (in testimony of which consent he has signed and sealed this scheme) and with the consent of the said Huyshe Wolcott, Bishop of Worcester (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal) and with the consent of the person to whom together with the said Lord Willoughby de Broke and the said Huyshe Wolcott, Bishop of Worcester, it is hereinafter recommended and proposed that the said advowson or perpetual right of patronage shall be transferred, that is to say, with the consent of Vivian Hugh Smith of Number 22, Old Broad - street, in the city of London Esquire (in testimony whereof he has signed and sealed this scheme) we, the said
