ARTICLE II.—These Regulations shall come into operation on the seventh day of June, one thousand nine hundred and nine.

SCHEDULE.

High-street, Puckeridge, comprising so much of the main road from Ware to Buntingford as extends from a point opposite the Roman Catholic Elementary School to a point in the road situate 200 yards north of its junction with the road next mentioned;

So much of the road leading from Puckeridge to Barkway as extends for a distance of 50 yards from its junction with High-street; and

So much of the road leading from Puckeridge to Standon as extends for a distance of 160 yards from its junction with High-street.
