In the Matter of the Patents and Designs Act, 1907, and in the Matter of Letters Patent bearing date the 22nd day of October, 1888, numbered 15159, and granted to **JAMES COULTHRED THOMPSON**, Gentleman, of Crescent-road, Brockley, S.E.
