ORDER of the Local Government Board: Motor Car Act, 1903: Regulations under Section 9 (1):—

COUNTY OF MIDDLESEX.

Urban District of Tottenham and Parish of Harlington.

To the County Council of Middlesex;—And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to

as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas We have received and duly considered applications from the County Council of Middlesex, for the issue of Regulations in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads situate within the urban district of Tottenham and the parish of Harlington, in the county of Middlesex:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:—

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the parts of roads which are specified in the Schedule hereto.

ARTICLE II. These Regulations shall come into operation on the twenty-first day of June, one thousand nine hundred and nine.

SCHEDULE.

Urban District of Tottenham.

So much of Broad-lane as extends from its junction with Talbot-road to its junction with Ferry-lane.

Parish of Harlington.

So much of the road known as Village-road, through the village of Harlington, as extends from a point therein situate 50 yards north of its junction with Brickfield-lane to a point therein situate 50 yards south of the southern corner of the Baptist Chapel in that road.
