W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned that is to say the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-second years of Her said late Majesty, chapter one hundred and the the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the eighteenth day of March, in the year one thousand nine hundred and nine, in the words following, that is to say;

that is to say; "We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of All Saints, Woodlesford, in the county of York and in the diocese of Ripon.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of All Saints, Woodlesford, is vested for an estate in fee simple without incumbrances in the Right Reverend Norman Dumenil John, now Bishop of Newcastle, Gerard Frederick Towlerton Leather, late of the Northumberland Fusiliers, but now of Middleton Hall, Belford, Northumberland, Sir Charles Bingham Lowther, of Swillington House, in the county of York, Baronet, and Henry Cumberland Bentley, of Nithsdale, Market Harborough, in the county of Leicester, Esquire, (hereinafter called the present Patrons).

"And whereas the present Patrons are desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of All Saints, Woodlesford, now vested in them as aforesaid should be transferred to and be vested in the Bishop for the time being of the said diocese of Ripon.

"And whereas the Right Reverend William Boyd, now Bishop of Ripon, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary he, the said William Boyd, Bishop of Ripon, has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of All Saints, Woodlesford, which is hereinbefore mentioned and hereinafter recommended and proposed, will render the same benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say in the new parish of All Saints, Woodlesford.

"Now therefore with the consent of the ' present Patrons (in testimony whereof they have signed and sealed this scheme) and with the consent of the said William Boyd, Bishop of Ripon (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of All Saints, Woodlesford, now vested in the present Patrons as aforesaid, shall be transferred to the said William Boyd, Bishop of Ripon, and his successors in the same Bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said William Boyd, Bishop of Ripon, and by his successors in the same Bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts, and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

"Whereas the whole advowson or perpetual right of patronage of and presentation to the said benefice of Llanfihangel ar Arth is vested free from incumbrances in certain undivided parts or shares respectively in William Price Llewellyn Lewes, of Llysnewydd Henllan, in the county of Cardigan, a Lieutenant-Colonel, retired, in His Majesty's Army, Augustus Brigstocke, of Blaenpant, Boncath, S.O., in the county of Pembroke, Esquire, and certain trustees upon trust in the first place for Thomas Gilbert Lloyd Elliott during his life.

"And whereas the said William Price Llewellyn Lewes, Augustus Brigstocke, and Thomas Gilbert Lloyd Elliott with the concurrence and approval of his said guardian are desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Llanfihangel ar Arth, should be transferred in the manner which is hereinafter recommended and proposed and the said Amy Constance Pease Elliott, as such guardian as aforesaid, is the person by whom, in accordance with the provisions of the before mentioned Acts and of the Act of the first and second years of Her said late Majesty, chapter one hundred and six, this scheme should be executed in testimony of the consent of the said Thomas Gilbert Lloyd Elliott.
