Contraction of Limits of Swine-Fever Infected Area.

1. The limits of the Swine-Fever Infected Area extended by Order of the Board dated the twentieth day of April, nineteen hundred and nine, are hereby contracted so as to comprise only the Area described in the Schedule to this Order, and the Area so described is hereby declared to be a Swine-Fever Infected Area for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908.

2. This Order shall come into operation on the sixteenth day of September, nineteen hundred and nine.
