PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the fourth day of November, in the year one thousand nine hundred and nine, in the words following, that is to say:—

“We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage

of and presentation to the church and cure (hereinafter called ‘the said benefice’) of Falfield, in the county of Gloucester and in the diocese of Gloucester.

“Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Falfield is vested for an estate in fee simple in possession free from incumbrances in certain trustees upon trust in the first place for Sir George Banks Jenkinson, Baronet, of Eastwood, in the county of Gloucester, during his life, and the said George Banks Jenkinson is therefore the Patron or person entitled to present or nominate to the said benefice in case the same were now vacant.

“And whereas the said George Banks Jenkinson is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Falfield should be transferred in the manner which is hereinafter recommended and proposed.

“And whereas the Right Reverend Edgar Charles Sumner, now Bishop of Gloucester, in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, has executed this scheme as hereinafter mentioned.

“And whereas the transfer of the patronage of the said benefice of Falfield which is hereinbefore mentioned and hereinafter recommended and proposed, will render the same benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the parish or district in or
