PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the fourth day of October, in the year one thousand nine hundred and nine, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of

Llanwinio, in the county of Carmarthen and in the diocese of Saint David's.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Llanwinio as to one undivided onethird part or share thereof is vested for an estate in fee simple free from incumbrances in William Parker Howell of Penrheol, in the county of Carmarthen aforesaid, a Lieutenant-Colonel, retired, in Your Majesty's Army, and as to another undivided one-third part or share thereof is vested for an estate in fee simple free from incumbrances in Edward Harold Morris, of Carmarthen, in the said county of Carmarthen, Gentleman, and as to the remaining undivided one-third part or share thereof is vested for an estate in fee simple free from incumbrances in certain trustees upon trust for the benefit of Anne Dangerfield, of Down House, Bromyard, in the county of Hereford, Widow, for her life, and as regards such last mentioned undivided one-third part or share she the said Anne Dangerfield is therefore the Patron or person entitled to present or nominate to the said benefice in case the same were now vacant.

"And whereas the said William Parker Howell, Edward Harold Morris and Anne Dangerfield are desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Llanwinio should be transferred to and be vested in the Bishop of the said diocese of Saint David's and his successors Bishops of the same diocese.

"And whereas the Right Reverend John, now Bishop of Saint David's, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that
