"And whereas the transfer of the patronage of the said benefice of Saint Mary, Buxted, which is hereinbefore mentioned and hereinafter recommended and proposed, will render the same benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the new parish of Saint Mary, Buxted.

"Now, therefore, with the consent of the said Fanny Coombe (in testimony of which consent she has signed and sealed this scheme), and with the consent of the said Charles John, Bishop of Chichester (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), and with the consent of the persons to whom together with the said Charles John, Bishop of Chichester, it is hereinafter recommended and proposed that the said advowson or perpetual right of patronage shall be transferred, that is to say, with the consent of the Reverend Benedict George Hoskyns, one of the Prebendaries of the Cathedral Church of Chichester, and now Vicar of the vicarage of Brighton aforesaid, the Reverend John Elton Halliwell, now Vicar of the vicarage of Saint Paul, Brighton aforesaid, Arthur Reginald Carew Cocks, now Vicar of the vicarage of Saint Bartholomew, Brighton aforesaid, and the Reverend Henry Fitzrichard Hinde, now Vicar of the vicarage of the Annunciation, Brighton aforesaid (in testimony whereof they have severally signed and sealed this scheme), we, the said Ecclesiastical Commissioners for Eugland, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint Mary, Buxted, shall be transferred to the said Charles John, Bishop of Chichester, Benedict George Hoskyns, Vicar of the vicarage of Brighton, John Elton Halliwell, Vicar of the vicarage of Saint Paul, Brighton, Arthur Reginald Carew Cocks, Vicar of the vicarage of Saint Bartholomew, Brighton, and Henry Fitzrichard Hinde, Vicar of the Annunciation, Brighton, and their successors in the Bishoprick of Chichester, the vicarage of Brighton, the vicarage of Saint Paul, Brighton, the vicarage of Saint Bartholomew, Brighton, and the vicarage of the Annunciation, Brighton, respectively as joint tenants, and shall there-upon and thenceforth become and be absolutely vested in aud shall and may from time to time be exercised by the said Charles John, Bishop of Chichester, Benedict George Hoskyns, Vicar of the vicarage of Brighton, John Elton Halliwell, Vicar of the vicarage of Saint Paul, Brighton, Arthur Reginald Carew Cocks, Vicar of the vicarage of Saint Bartholomew, Brighton, and Henry Fitzrichard Hinde, Vicar of the Annunciation, Brighton, and their successors respectively in the said Bishoprick of Chichester and in the said vicarages as joint tenants for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament." And whereas the said scheme has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirtynine, and the Act of the thirty-first and thirtysecond years of Her said late Majesty, chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the sixteenth day of December, in the year one thousand nine hundred and nine, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty-fourth years of Her late Majesty Queen Victoria, chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty, chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty, chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty, chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Frampton-on-Severn, in the county and diocese of Gloucester.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Frampton-on-Severn is vested for an estate in fee simple in possession free from incumbrances in the Reverend Ernest Wollaston Silver, of the Rectory, Brighstone, in the Isle of Wight, Clerk in Holy Orders.

"And whereas the said Ernest Wollaston Silver is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Frampton-on-Severn, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Edgar Charles Sumner, now Bishop of Gloucester, and his successors in the same Bishoprick.

"And whereas the said Edgar Charles Sumner, Bishop of Gloucester, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act
