recited or by some or one of them is made necessary, he the said Edgar Charles Sumner, Bishop of Gloucester, has executed this scheme

as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Frampton-on-Severn, which is hereinbefore mentioned and hereinafter recommended and proposed, will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the

parish of Frampton-on-Severn.

"Now therefore with the consent of the said Ernest Wollaston Silver (in testimony whereof he has signed and sealed this scheme), and with the consent of the said Edgar Charles Sumner, Bishop of Gloucester (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted ()rder the whole advowson or perpetual right of patronage of and presentation to the said benefice of Frampton-on Severn now vested in him the said Ernest Wollaston Silver as aforesaid, shall be transferred to the said Edgar Charles Sumner, Bishop of Gloucester, and his successors in the same Bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edgar Charles Sumner, Bishop of Gloucester, and by his succes sors in the same Bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any

other Act of Parliament."

And whereas the said scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Gloucester.

W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, and of the Act of the thirty-seventh and thirty-eighth years of Her said late Majesty

chapter sixty-three, duly prepared and laid before His Majesty in Council a scheme bearing date the sixteenth day of December, in the year one thousand nine hundred and nine, in the words

following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, and of the Act of the thirty-seventh and thirty-eighth years of Her said late Majesty, chapter sixty-three, have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a new archdeaconry within the diocese of Worcester, and for endowing such new archdeaconry.

"Whereas the said diocese of Worcester now comprises two archdeaconries and no more, namely, the archdeaconry of Worcester and the

archdeaconry of Coventry.

"And whereas the Right Reverend Huyshe Wolcott, Bishop of Worcester, has represented to us and it appears to us to be expedient that a new archdeaconry should be constituted within the said diocese of Worcester, and should comprise the rural deaneries of Alcester, Blockley, Evesham, Feckenham, North Kineton, South Kineton, Pershore, and Warwick, which are at present within the said archdeaconry of Worcester and within the said diocese of Worcester, that such new archdeaconry should be endowed in the same manner which is hereinafter recommended and proposed.

"And whereas it appears to us to be undesirable that procurations, synodals, visitation fees and induction fees should be received by the archdeacon of the said proposed new arch-

deaconry.

"And whereas it has been made to appear to us that by reason of the discontinuance of the collection of the said fees there will be no annual income available for the said proposed archdeacoury from fees, dues, and emoluments, and that the grant hereinafter recommended and proposed will not be such as to raise the annual income of the said proposed archdeacoury to an amount exceeding two hundred pounds.

"Now therefore we, the said Ecclesiastical Commissioners for England, with the consent of the said Huyshe Wolcott, Bishop of Worcester (testified by his having signed and sealed this scheme), humbly recommend and propose that upon and from the day upon which any Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order, one new archdeaconry shall be created within the said diocese of Worcester, and that such archdeaconry shall be named 'the archdeaconry of Warwick,' and shall comprise and consist of the said rural deaueries of Alcester, Blockley, Evesham, Feckenham, North Kineton, South Kineton, Pershore, and Warwick.

"And we further recommend and propose that the rural deans and other the clergy and the inhabitants generally of the said proposed archdeaconry of Warwick shall be under and subject to the archidiaconal jurisdiction, authority, and control of the Archdeacon of such proposed archdeaconry for the time being, and that such Archdeacon shall have and exercise all the rights, powers, and duties of an Archdeacon within the limits of his archdeaconry.

"And we further recommend and propose that we be authorized to pay by half-yearly instalments on the first day of January and the first
