##### LLANDOVERY FAIRS.

#### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday, the 14th instant, at one o'clock, for Treasury Bills to be issued to the amount of £5,000,000, in part replacement of Bills falling due on the 17th instant.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 17th March, 1910, and will be payable at six months after date, viz.:—on the 17th September, 1910.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 15th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock on Thursday, the 17th March, 1910.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
