The KING has been pleased, by Letters Patent under the Great Seal, to grant unto Thomas Edward Scrutton, Esq., K.C., the office of one of the Justices of His Majesty's High Court of Justice.

Whitehall, April 19, 1910.

His Majesty The King has been pleased to award the Edward Medal of the Second Class to Hannah Hugill :---

On the 11th September, 1909, Mrs. Hugill, on going into a field at Court House Farm, Great Busby, with her daughter to bring in some cows, was attacked by an infuriated bull. She defended herself with a pitchfork, but was knocked down by the bull, which commenced to gore her. Her daughter, Hannah, aged 15 years, who had been left at the gate, about a hundred yards from the place where her mother was attacked, came to her aid, and, recovering the

fork from under the bull, used it with all her strength, thus diverting the animal's attention.

The mother and daughter then succeeded in making good their escape from the field, though the mother was again attacked while crossing the fence. The girl's action saved her mother from severe and, possibly, fatal injury.

The KING has been pleased to grant unto John William Handley Davenport-Handley (formerly John William Handley Davenport), of Clipsham Hall, and of Pickworth Park, both in the county of Rutland, Deputy Lieutenant for the said county, and in the Commission of the Peace for that county and for the County Palatine of Chester, sometime Sheriff for the county of Rutland aforesaid, His Royal licence and authority; that he may take and use the surname of Humphreys in addition to and after his present surnames of Davenport-Handley, and that he may bear the arms of Humphreys quarterly with those of Davenport and Handley, and that such surname and arms may in like manner be taken, borne and used by his issue; the said arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in His Majesty's College of Arms.
