WHEREAS His Majesty was pleased, by His Commission dated the fifth day of March, one thousand nine hundred and ten, to nominate and appoint His Royal Highness The Prince of Wales, in His Majesty's absence from His Realm in Foreign Parts, to hold on His Majesty's behalf, His Privy Council, and to signify thereat His approval of any matter or thing whereunto His Royal Highness should be authorized by writing under His Majesty's Sign Manual, and to do further on His Majesty's behalf any matter or thing for the purposes of the said Commission whereunto His Royal Highness should be authorized in manner aforesaid :

And whereas there was this day read at a Council held by His Royal Highness under the authority of the said Commission a Representation made by the Local Government Board to His Majesty in Council under the provisions of the Burial Act, 1853 (ten days' previous notice of their intention to make such Representation having, in accordance with the provisions of the said Act, been given by the Local Government Board to the Incumbent and the Churchwardens of the parish of Narborough, in the county of Leicester), to the effect that, for the protection of the public health, the opening of any new burial ground in the civil parish of Narborough aforesaid, save with the previous approval of the Local Government Board, should be prohibited, and that burials should be discontinued therein, as follows, viz. :-

NARBOROUGH.-Forthwith and entirely in the parish church of All Saints, Narborough, and the churchyard attached thereto, and in the Narborough Congregational Chapel and the graveyard attached thereto, with the following exceptions, that is to say :

(a.) In any vault or walled grave now existing in the said churchyard or the said graveyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented;

(b.) In any earthen grave now existing in the said churchyard or the said graveyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave; subject to the condition that no part of the coffin containing the body shall in any case be at a depth less than three feet from the level of the surface of the ground adjoining the grave.

Now, therefore, His Royal Highness The Prince of Wales being authorized thereto by writing under His Majesty's Sign Manual, doth hereby, by and with the advice of His Majesty's Privy Council, on behalf of His Majesty, give notice of such representation, and order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council, on the first day of June next.

And His Royal Highness, being so authorized as aforesaid, doth hereby further, on behalf of His Majesty, direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches within, the parish affected by such representation one month before the said first day of June next.
