Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Stainburn, in the county of York and in the diocese of Ripon.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the fourteenth day of January, in the year one thousand eight hundred and seventy-one, and published in the London Gazette on the seventeenth day of the same month, part of the parish of Kirkby Overblow, in the said county of York and in the said diocese of Ripon, was assigned as a district chapelry to the consecrated church, situate within the limits of the township and chapelry of Stainburn, in the said parish of Kirkby Overblow, and the said district chapelry was named 'The District Chapelry of Stainburn.'

"And whereas the said district chapelry of Stainburn has, under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, become a new parish of the character contemplated by that Act, by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Stainburn should be altered in the manner which is hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend William Boyd, Bishop of the said diocese of Ripon (in testimony whereof he has signed and sealed this scheme or representation) we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Stainburn shall be altered so that all that portion of the said parish of Kirkby Overblow, which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink, shall be dissevered from such parish and shall be annexed to and shall in future form part of the said new parish of Stainburn.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the parish of Kirkby Overblow, in the county of York and in the diocese of Ripon, and to be annexed to the new parish of Stainburn, in the same county and diocese, being :---

"All that portion of the said parish of Kirkby Overblow which is comprised within and is co-extensive with the township or civil parish of North Rigton."

And whereas drafts of the said scheme or representation have been transmitted to the Patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such Patrons and Incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Parish of Manchester Division Act, 1850, that is to say, the Act of the thirteenth and fourteenth years of Her late Majesty Queen Victoria, chapter fortyone, and of the Act of the nineteenth and twentieth years of Her said late Majesty chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following scheme for setting out and constituting a separate district for spiritual purposes, and annexing such district to the consecrated church of Saint Matthew, Crumpsall, situate within the limits of the parish (sometime a district under the said Parish of Manchester Division Act, 1850) of Saint Mary, Crumpsall, within the original limits of the parish of Manchester, in the county of Lancaster and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district for spiritual purposes comprising a portion of the said parish of Saint Mary, Urumpsall, and also a portion of the parish of Saint Mark, Cheetham Hill (which last named parish is within the original limits of the said parish of Manchester, and was formed as a district under the said Parish of Manchester Division Act, 1850), should be set out and constituted for and annexed to the said church of Saint Matthew, Crumpsall, which church was not consecrated under the provisions of the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven.

"Now, therefore, with the consent of the Right Reverend Edmund Arbuthnott, Bishop of the said diocese of Manchester (testified by his having signed and sealed this scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said parish of Saint Mary, Crumpsall, and of the said parish of Saint Mark, Cheetham Hill, which
