the 20th March, 1906, and numbered 23A, have been made by the Secretary of State.

Now I, hereby, in pursuance of the said provisions amend these Rules as follows:—

I. The following Rule, to be numbered 4A, shall be inserted after Rule 4: "Where the Immigration Officer receives notice of appeal from an immigrant he shall inform the immigrant that he has the right to have legal assistance in presenting his appeal to the Immigration Board, but that the expense of any such legal assistance must be borne by the immigrant himself."

II. Rule 23, dated the 19th December, 1905, shall be read and have effect as though the words "and his legal representative (if any)" were inserted after the words "The immigrant" in line 1.
