WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the third and fourth years of Her said late Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the twelfth day of May, in the year one thousand nine hundred and ten, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the third and fourth years of Her said late Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Barnabas, Morecambe, situate in the new parish (sometime district chapelry) of Poulton, in the county of Lancaster and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Barnabas, Morecambe, situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Edmund Arbuthnott, Bishop of Manchester (testified by his having signed and sealed this representation), we, the said
