### ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

#### (Dated 12th July, 1910.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts :

1. And whereas it is expedient, in the interest of public convenience, that Acton Sub-district of Brentford Registration District should be divided into two Sub-districts to be constituted as follows, viz. :--(a) a Sub-district to be called and known as Acton Sub-district, and to consist of the Civil Parish and Urban District of Acton; and (b) a Sub-district to be called and known as Hanwell Sub-district, and to consist of the Civil Parish of Hanwell (Hanwell Urban District) and the Civil Parishes of Greenford and Perivale (both Parishes comprised in Greenford Urban District); and whereas it is expedient further to transfer the Civil Parish of Twyford Abbey (the remaining part of Greenford Urban District) from Brentford Sub-district of Brentford Registration District to Hanwell Sub-district of the same Registration District (as constituted by this Order).

2. Now, therefore, I, Bernard Mallet, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order

and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on 1st day of August, nineteen hundred and ten.

# ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

# (Dated 13th July, 1910.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts :-

1. And whereas it is expedient, in order that certain of the Sub-districts of Greenwich Registration District may include entire Wards of Deptford Metropolitan Borough: (a) that the parts of the North and North-West Wards now situated in Deptford Central Sub-district should be transferred to Deptford North Sub-district; (b) that the part of the South-West Ward now situated in Deptford Central Sub-district should be transferred to Deptford South Sub-district; and (c) that the part of the East Ward now situated in Deptford North Sub-district should be transferred to Deptford Central Sub-district; and whereas it is also expedient that St. Nicholas, Deptford Ward of Greenwich Metropolitan Borough now situated in Deptford North Subdistrict of Greenwich Registration District should be transferred to Deptford Central Sub-district of the same Registration District, and that the latter Sub-district as altered by this Order should be re-named Deptford East Sub-district.

2. Now, therefore, I, Bernard Mallet, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on 1st day of August, nineteen hundred and ten.
