

burials should be solemnized or performed at the said church of Saint Margaret, situate at Frizinghall as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the Minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Margaret, Frizinghall, being:—

"All that part of the new parish (sometime district chapelry) of Saint Barnabas, Heaton, in the county of York and in the diocese of Ripon, which is bounded upon the east partly by the new parish of Saint James, Bolton, and partly by the new parish of Christ Church, Windhill, upon the north and upon the north-west by the district parish of Shipley-cum-Heaton, all in the said county and diocese, and upon the remaining sides, that is to say, upon the west and upon the south, by an imaginary line commencing upon the boundary which divides the said district parish of Shipley-cum-Heaton from the said new parish of Saint Barnabas, Heaton, at the junction of the road called Norwood-avenue with Bradford-road, and extending thence first south-eastward, and then southward along the middle of Bradford-road and along the middle of Keighley-road for a distance in all of forty-five chains and a half or thereabouts to a point opposite to the western end of the wall or fence forming the southern boundary of the house and premises known as Number 258, Keighley-road, and extending thence eastward to and along the said wall or fence and along the walls or fences forming the southern boundaries of the houses and premises on the southern side of the road called Park-grove, of the close numbered 2449 upon the Ordnance Map of the civil parish of Bradford published in the year one thousand nine hundred and eight upon the scale of twenty-five inches to a mile and also upon the map or plan which is annexed to this representation, and of the house and premises known as Oak Wood, for a distance in all of eight chains and a half or thereabouts to the eastern end of the last mentioned wall or fence upon the western side of Frizinghall-road, and extending thence first eastward to and then northward along the middle of Frizinghall-road for a distance of two chains and a half or thereabouts to a point opposite to the western end of the wall or fence forming the southern boundary of the house and premises known as the Poplars, and extending thence eastward to and along such wall or fence and along the walls or fences forming the southern boundaries of the house and premises known as Old Hall and of the close numbered 2,602 upon the said maps for a distance in all of eleven chains and a half or thereabouts to the point where the last-mentioned wall or fence meets the fence forming the western boundary of the Leeds and Bradford Branch Line of the Midland Railway, and extending thence in a straight line due east (thereby crossing the said line of railway) for a distance of two chains or

thereabouts to a point on or near the eastern side of Canal-road upon the boundary which divides the said new parish of Saint Barnabas, Heaton, from the said new parish of Saint James, Bolton."

And whereas the said representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

WHEREAS by section 6 (1) of the Southend-on-Sea Corporation Act, 1909, it is provided that the Borough of Southend-on-Sea shall be divided into such number of wards and the wards shall have such names or distinguishing numbers and boundaries as shall be determined by a scheme to be made by a Commissioner to be appointed for that purpose by His Majesty's Principal Secretary of State for the Home Department:

And whereas His Majesty's Principal Secretary of State for the Home Department did, on the twenty-second day of September, one thousand nine hundred and nine, appoint Raymond Asquith, Esquire, Barrister-at-Law, a Commissioner for the purpose aforesaid:

And whereas the said Commissioner has made and has, in accordance with the provisions of section 30 (11) of the Municipal Corporations Act, 1882, sent to His Majesty's said Principal Secretary of State, to be submitted by him to His Majesty in Council for approval, a scheme dated the third March, one thousand nine hundred and ten, in the words and figures following:—

"Article I.

"This Scheme shall except so far as is otherwise herein expressly provided or as there may be anything in the subject matter or context inconsistent therewith come into operation for the purpose of all proceedings preliminary to the ordinary Municipal Elections of the year one thousand nine hundred and ten on the date of its publication in the London Gazette and for all other purposes on the first day of November, one thousand nine hundred and ten.

"Article II.

"Subject as regards any future alteration of the wards hereby constituted to the provisions of the Municipal Corporations Act, 1882, and any Act amending the same as to the alteration of wards the following provisions shall have effect:—

"(1) Whereas heretofore the borough has been divided for the purpose of the election of Councillors into three wards, termed respectively the Prittlewell or North Ward,
