The KING's Most Excellent Majesty in Council.

THEREAS the Ecclesiastical Commissioners W for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the ninetcenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the fourteenth day of July, in the year one thousand nine hundred and ten, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His late Majesty King George the

Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Michael, situate at Cricklewood, in the new parish (sometime consolidated chapelry) of Saint Gabriel, Willesden Green, in the county of Middlesex and in the diocese of London.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Michael, situate at Cricklewood as aforesaid.

"Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said new parish of Saint Gabriel, Willesden Green, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Michael, situate at Cricklewood as aforesaid, and that the same should be named 'The District Chapelry of Saint Michael, Cricklewood.'

"And with the like consent of the said Arthur Foley, Bishop of London (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Michael, situate at Cricklewood as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Michael, Cricklewood, being :-

"All that part of the new parish (sometime consolidated chapelry) of Saint Gabriel, Willesden Green, in the county of Middlesex and in the diocese of London, which is bounded upon the south-west by the new parish of Saint Andrew, Willesden, upon the north-west by the new parish of Neasden-cum-Kingsbury, upon the north-east by the new parish of Saint Peter, Cricklewood, all in the said county and diocese, and upon the remaining sides, that is to say, upon the south-east and upon the south by an imaginary line commencing upon the boundary which divides the said new parish of Saint Peter. Cricklewood, from the said new parish of Saint Gabriel, Willesden Green, at the junction of Cricklewood Broadway with Ashford-road, and extending thence south-westward along the middle of
