# THE WILD BIRDS (SUNDAY) PROTECTION (COUNTY OF FORFAR) ORDER, 1910.

#### Dated 8th July, 1910.

In pursuance of the powers conferred upon me by the Wild Birds Protection Acts, 1880 to 1904, and upon application by the County Council of the County of Forfar, I, the undersigned, His Majesty's Secretary for Scotland, do hereby make the following Order:—

1. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not apply, the taking or killing of any Wild Bird on Sundays (save as hereinafter provided), is prohibited throughout the County of Forfar.

2. The provisions of this Order shall not apply to the Crow or to the Wild Pigeon.

3. This Order may be cited as "The Wild Birds (Sunday) Protection (County of Forfar) Order, 1910."
