To the County Council of Buckingham; And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of Buckingham having made application to Us to make a Regulation in pursuance of the said sub-section putting the above mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads in the parish of Burnham, in the county of Buckingham, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon :

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our

of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads or parts of roads within the parish of Burnham which are specified in the Schedule hereto.

ARTICLE II.-These Regulations shall come into operation on the twenty-fifth day of July, one thousand nine hundred and ten.

SCHEDULE.

High-street, extending from the northern extremity of North End Cottages to its junction with the road leading to Stomp-road;

So much of Gore-lane as extends for a distance of 100 yards from its junction with High-street; So much of Britwell-road as extends from its

junction with High-street to its junction with the road next hereinafter mentioned; and

So much of the road branching from Britwellroad aforesaid and passing along the south-west side of the Gables Garden to Burnham Cottage as extends for a distance of 40 yards from its junction with that road.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of Middlesex having applied to Us to make Regulations in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising a certain road within the Urban District of Sunbury-on-Thames, We caused a Local Inquiry to be made by one of Our Inspectors into the subjectmatter of that application, and the Report of the Inspector has been received and considered by Us:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations :-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the portion of Thames-street in the Urban District of Sunbury-on-Thames, which extends from its junction with Halliford-road to its junction with French-streei.

ARTICLE II.—These Regulations shall come into operation on the twenty-fifth day of July, one thousand nine hundred and ten.

YORKSHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1910.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1909, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Movement into out of or within Scheduled District.

1. No cattle, sheep, goats, or swine shall be moved into or out of the District described in the Schedule to this Order, hereinafter referred to as the Scheduled District, or be moved along over or across a highway or thoroughfare within the Scheduled District; provided that nothing in this Order shall be deemed to apply to the movement of animals into or out of the Scheduled
