of twelve months thereafter, pay to the said Governors, their successors or assigns, onetenth part of the said principal sum until the whole thereof shall be repaid, and shall also at the end of the first and each succeeding period of twelve months, computed as aforesaid, pay interest at the rate of four pounds per centum per annum on the said principal sum or on so much thereof as shall from time to time remain unpaid. that, if and when it shall happen that either the principal or the interest directed to be paid as hereinbefore mentioned shall be in arrear and unpaid for the space of forty days after the same shall become due, it shall and may be lawful for the said Governors, their successors and assigns, to recover the same and the costs and charges attending the recovery thereof, by dis-tress and sale in the like manner as rents may be recovered by landlords or lessors from their tenants by the laws in force at the time of such distress and sale, and that such mortgage deed shall be in the form and to the effect to be approved by us, the said Ecclesiastical Commissioners, and shall bind as well the said Edward Lee, now Bishop of the said diocese of Lincoln, as every succeeding Bishop of the same diocese, until the principal money and interest, costs and charges shall have been paid off and

"And we further recommend and propose that the said sum so to be borrowed as aforesaid shall be paid to us, the said Ecclesiastical Commissioners, and that the receipt of our Joint Treasurers for the time being endorsed on the said mortgage deed shall be a good and sufficient discharge of the said Governors and their successors for the same, who shall not be bound or required to see to the application thereof, and that upon the receipt of the said sum so to be borrowed as aforesaid the whole or any part or parts thereof shall be applied by us at such times and in such manner as shall appear to us to be expedient towards effecting the said proposed improvements at the episcopal house of

residence aforesaid.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in conformity with the provisions of the hereinbefore mentioned Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been

approved by His Majesty in Council:
Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Lincoln.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late

the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four; and of the Act of the thirty-second and thirtythird years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the thirtieth day of June, in the year one thousand nine hundred and ten, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Peter, Hastings. in the county of Sussex, and in the diocese of Chichester.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the fifteenth day of August, in the year one thousand eight hundred and ninety, and published in the London Gazette on the nineteenth day of the same month, a certain part of the parish of Saint Paul, situate within the borough of Hastings, in the said county of Sussex and in the said diocese of Chichester, was assigned as a district chapelry to the consecrated church of Saint Peter, Hastings, situate in the said parish of Saint Paul, and the said district chapelry was named 'The District Chapelry of Saint Peter, Hastings.

"And whereas the said district chapelry of Saint Peter, Hastings, has, under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, become a new parish of the character contemplated by that Act, by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, and by the above mentioned Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four.

"And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said new parish of Saint Peter, Hastings, shall be altered in the manner which is hereinafter mentioned.

"Now therefore with the consent of the Right Reverend Charles John, Bishop of Chichester (in testimony whereof he has signed and sealed this scheme or representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Saint Peter, Hastings, shall be altered so that all that portion of the said parish of Saint Paul, Hastings, which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such parish and shall be annexed to and shall in future form part of the said new parish of Saint Peter, Hastings.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending or proposing any other measures relating to Majesty Queen Victoria, chapter ninety-four; of I matters aforesaid or any of them in accordance
